- Retiree Annual Selection Dates October 25 November 12
- Hearing Aid Benefit being added to all pre- 65 plans and post-65 Medigap plans.
 - Allowance of up to \$4000 per person (not per ear) every 3 years.
- 2022 is a Retiree Dental Enrollment Year (three year lock in)
- Adding VSP Vision Plan
- Small Increase in rates
